## 16/1060 VILLAGE MAINTENANCE/HANDYMAN

**Maintenance equipment.** The council members looked at two strimmer/hedge trimmer combisystems for use by the handyman: Mitox and Stihl. It was decided to go ahead with Stihl, as it is more robust, whereas the Mitox is designed for domestic use. H Webster will check online prices to compare with those obtained from Ibbetts. H Webster also kindly offered to donate his Stihl brushcutter attachment to the parish council free of charge, which will bring down the cost. **Pavilion.** The toilet repair is in-hand with AA Taylor.

**Dog fouling.** Complaints have been received about the amount of dog waste in the grass by the lock-up, despite a dog waste bin being sited there. The handyman will try to speak to the offending dog-owner.

Some dog owners are still letting their dogs run around the playing field and are not picking up their dog waste, despite signs stating dogs should be kept on leads. If this continues the parish council may ban dogs from the playing field altogether in the interest of hygiene.
