PARISH COUNCIL OPEN FORUM

Opened at 19.35.

A resident highlighted the problem with HGV traffic through the village during A14 night closures over the weekend of 2/3 June. He has contacted Bob Pettipher who will try to visit Horse and Gate Street. There are further issues of the narrowing of Horse and Gate Street for repairs to a property and a burst water main and a blocked storm drain. The resident was also concerned that the traffic island opposite the Shell Garage in Huntingdon Road was encroaching Fen Drayton parish. The council members were satisfied that it is within the Fenstanton boundary.

18/1244 COUNCILLORS' REPORTS

Cllr Sue Ellington: following the full council meeting the cabinet will be reduced to the leader, Cllr Bridget Smith and deputy leader Cllr Aidan Van de Weyer. Finance portfolio – Cllr John Williams, planning – Cllr Tumi Hawkins, housing – Cllr Hazel Smith, environment – Cllr Neil Gough, business and staffing – Cllr Philippa Hart.

Cabinet members will attend parish council meetings if invited. There seems to be a desire to return to the committee system, subject to the agreement of the civic affairs committee. In opposition, the conservative group continues to be led by Cllr Peter Topping, with Cllr Nick Wright as deputy and shadow planning and Cllr Mark Howell as shadow housing. Cllr Ellington is shadow environmental services; Cllr Grenville Chamberlain is shadow finance and chairman of scrutiny.

The five-year land supply has been achieved but by a small margin. The plan is still awaiting ratification and the new administration has a problem as several councillors were elected as they wanted to stop building on Bourn Airfield and Waterbeach barracks, both parts of the proposed plan to be agreed. Failure by the council to agree the government's accepted plan would result in further speculative housing developments.

The greater Cambridge partnership continues to be at loggerheads with the mayor, who wants to take it over. The new district council was voted in on the basis of its opposition to the GCP's transport to Cambourne plans, then discovered that the mayor's plans were even more unacceptable, so it has had to reverse its opinion of the GCP's plan.

From a health perspective Cllr Ellington is disappointed that there is no lead or anyone in the cabinet with knowledge of health issues. However, plans agreed before the election must be enacted during this year, so Cllr Ellington will keep an eye on it.

Finally, Parklife, SCDC's free family fun day, will be held on 1 July in Milton Country Park.
