Clerk has reported litter from Shell Garage to Hunts CC and complained about HGVs parking on the verge at the end of Mill Road (see correspondence).

Letters have been sent to Hall Court management and to 4 and 27 Cootes Lane re hedges overgrowing the pavement/cycle path.

Dead tree near village hall entrance: J Isden to ask Atlas to survey as soon as possible. Quotation from AATaylor for replacing a shower in pavilion = £253.00.

A villager has queried why four trees in the park, near Park Lane, have been coppiced.

17/1118 MATTERS ARISING FROM VILLAGE MEETING

Complaints about traffic through the village: a resident is looking at obtaining a grant from the A14 community fund to pay for traffic calming/HGV restrictions.

17/1119 AFFORDABLE HOUSING & RECREATION EQUIPMENT

Affordable housing: J Isden reported on the Affordable Housing Mythbuster Tour. BHPA has agreed to sponsor Fen Drayton's housing needs survey in September.

Recreation equipment: J Isden looked at two items from Caloo for older village children: a Triple Access C and outdoor table tennis. The cost for both + a SUDS floor would be around £15K. This could be funded from the S106/Town Lands funds.

That the parish council goes ahead and requests a quotation from Caloo was proposed, seconded and unanimously approved. (CG/JC)
