PARISH COUNCIL MEETING

Opened at 19.30.

Owing to police work commitments, PCSO Baugh had to leave at 19.50, so item 859 was brought forward to 19.30.

859. LOCAL CRIME/PCSO

Six crimes were reported in Fen Drayton over the past three months: a break-in and theft at business premises in Huntingdon Road, two pedal cycles stolen from the guided bus stop, a registration plate removed from a vehicle The Plantation and an exhibition trailer stolen from the main car park and a picnic table vandalised in the nature reserve.

PCSO Baugh advised that a Modern Day Slavery summit is being held on 17 October. Its main objective is to raise awareness and advise on how to identify possible cases of slavery. He would like a resident of Fen Drayton to attend.

PARISH COUNCIL OPEN FORUM

Opened at 19.36

Five residents of Horse and Gate Street were present to highlight the problems caused by HCV traffic in the street especially in view of the A14 upgrade. A14 construction traffic will not come through the village, but non-construction HCVs may still use Fen Drayton as a rat-run when there are hold-ups on the A14. The possibility of a weight restriction was discussed, with a view to it being funded by the LHI (see item 864). A weight restriction would require evidence from residents, such as proof of damage to property caused by HCVs and a survey of HCV numbers. Cllr Wright advised that it is likely that the parish council would have to fund this itself due to lack of county council funds.

The chair has recently written to all residents of Horse and Gate Street. So far three replies have been received.

863. VILLAGE LANDSCAPING/TREES/MAINTENANCE

Tree safety: Fen Drayton has no tree wardens. The handyman checks the village trees. Having a tree warden will be discussed again next month. In the meantime councillors and the clerk will ask around to see if anyone is interested in the position.

J Christie proposed, seconded by C Gray, that another dog waste bin be purchased by the clerk from Glasdons (£84 + VAT) to be positioned near the lock-up.

VERMUYDEN WAY/COOTES LANE CORNER: the council now has a quotation from P Larter of £1100 + VAT for clearing, levelling and grassing the area and retaining existing viable trees and shrubs. A planted or rock border will be put in to prevent cars parking on the grass. C Gray, seconded by R Lewis, proposed to accept P Larter's quotation; all in favour. Atlas has quoted for removing the dead willow in Vermuyden Way (£580 + VAT) and three dead elms by the village hall entrance (£680 + VAT). Accepting the quotations from Atlas was proposed by R Lewis and seconded by C Gray; all in favour.

- ACTION: J Christie to progress landscaping of Cootes Lane corner.
- ACTION: Clerk to purchase dog waste bin.

864. LOCAL HIGHWAYS IMPROVEMENT (LHI) SCHEME

LHI guidance notes were forwarded to all councillors by email on 16 July. The cut off date for the scheme is 2 November. The parish council will apply for funding for a weight restriction in Horse and Gate Street via the LHI scheme in the first place.

• ACTION: H Webster to continue to deal.

865. FOOTBALL FUNDING/PAVILION

J Isden has met with the Fen Drayton Lions football club. Three options: replace the pavilion with a new wood structure; replace with a purpose built unit (such as a MAC) or continue to repair as necessary. C Gray contacted the Football Foundation and found a contact, Alan Lamb, for free advice on the pavilion/funding, which she will follow up.

• ACTION: C Gray to contact Alan Lamb.

866. A14 UPDATE

Letter received on 7 September confirmed that access to the Town Lands field would be provided. There will be no bridge over the A14 to Conington. There will be no funds available for traffic calming in the village. The county council deals with weight restriction issues.

867. NOTICE BOARD/VILLAGE NEWSLETTER

Complaints have been received about the lack of a notice board at the Mill Road end of the village. An alternative could be an electronic newsletter available online.

• ACTION: clerk to investigate online newsletter.

Complaints have also been made about the lack of space on the notice board at the junction of High Street and Cootes Lane. The clerk will print out a guidance notice to go on the board banning notices larger than A4.

868. PARKING

H Webster attended the Histon Sector Panel Meeting on 5/8/2015 where the policing of parking problems was discussed.

A complaint about parking in College Farm Court was emailed to the parish council but representatives did not attend the meeting so no further action was taken.

870. FINANCE

The Town Lands Rent Review is due on 29 September 2016. The parish council has to serve notice to the tenant by 26 September 2015 and then follow up with a proposal of a rent increase in the middle of next year. Advice has been taken from a land agent, whose fees are £125 plus VAT. H Webster, seconded by J Christie, proposed that these should be accepted. All in favour.

Charges for sale of enclosure maps. Nine orders have been received. J Christie has received a quotation for £129 for 10 copies. J Christie, seconded by C Gray, proposed to go ahead with the order as quoted. All in favour.

• ACTION: J Christie to order copies of the enclosure map.

In the light of previous problems (also experienced by other parish and town councils) the clerk suggested changing banks to gain online services to facilitate cheque authorization, adding signatories, etc. The clerk will investigate alternatives and report back next month.

ACTION: clerk to investigate alternative banking services.

A £20 donation was received from Cambridge Rugby Club.

A new contract for the parish council phone has been taken out at £7 pm (it was previously £10 pm).
